

**Sub: - Regularization of services of Finance Assistants of JKSPDC.**

ORDER NO. PDC/CJ/ 30 of 2017  
 DATED 24 -01- 2017

Whereas; 62 candidates were appointed as Finance Assistants in the JKSPDC vide order No. PDC/CJ/100 of 2014 dated 28-02-2014 on contractual basis for a period of 2 years.

Whereas; 10 candidates did not report for duties after their appointment in the JKSPDC out of the said lot.

Whereas; 10 substitute candidates were appointed as Finance Assistants on contractual basis for a period of 2 years vide order No. JKSPDC/ADM/EG-258/3075 dated 11-07-2014 on the condition that their services shall be regularized subject to their good performance, after attaining 2 years successful service.

Whereas; out of the 10 fresh appointees only 5 candidates joined the contractual service as Finance Assistants, in the JKSPDC.

Whereas; after attaining 2 years contractual service the issue was tabled before the In-house Committee for consideration of the regularization of the services of 5 Finance Assistants in the JKSPDC who recommended their regularization from the dates as reflected against each.

In view of the satisfactory performance of 5 Finance Assistants during 2 years contractual service and thereafter, as well as recommendations of the In-house Committee, sanction is accorded to the regularization of services of the following Finance Assistants in the Pay scale of Rs. 9200-20200+ GP Rs. 2400 from the dates and with the allotment of posts of Finance Assistants to the offices as shown hereunder:-
